The Submission MUST be time stamped or postmarked on or before October 15, 2020. The dealer invoice must satisfy the criteria listed in one of the following tiers to qualify for the corresponding rebate: Tier 1: \$200 rebate - requires a minimum purchase of 650 sf James Hardie® brand siding, 400 sf HardieTrim® boards, and 500 sf HardieSoffit® panels.
